




## **KINDERGARTEN**

#### Minutes of the ICS Annual Society Meeting June 4, 2025 7:00 p.m.

- Article 1: Opening prayer and devotions were given by Board President Todd Reinke.
- Article 2: Minutes of the June 5, 2024, Society Meeting were read for information. Motion made, supported, and carried to approve the minutes as read.
- Article 3: Count off was held with 35 members in attendance. Todd Folkerts and Brian Stearns were appointed tellers.
- Article 4: 3 absentee ballots were turned in. Motion made, supported, and carried to approve the absentee ballots
- Article 5: Voting was held for one school board member for a three-year term, the nominees are Brian Blankespoor, Delmar Scholten and Matt Vande Vegte. Retiring board member is Darren Davelaar. Todd Reinke will be returning for an additional three-year term which was voted on by the board.
- Article 6: Voting was held for two new foundation board members for a three-year term, the nominees are Jim Bleeker, Mike Knobloch, Galen Vande Vegte and Heath Van Voorst. Retiring board members are Jim Bleeker and Dale Kollis
- Article 7: Voting was held on amending the process for having Board Members serve a second term. Current Policy Wording:

A Board consisting of (6) members shall be elected by the Society. The term of Board Members shall be three (3) years. Retiring Board Members are eligible for a second term. Board members willing to serve a second term need to be approved by a simple board majority vote by ballot. Board Member seeking re-election will not be allowed to vote. Proposed Amendment:

A Board consisting of (6) members shall be elected by the Society. The term of Board Members shall be three (3) years. Retiring Board Members are eligible for a second term. Board members willing to serve a second term need to be approved by a simple board majority to go on the ballot, along with the new nominees. Board Member seeking re-election will not be allowed to vote. The Society will then vote for all the nominees who they feel are qualified to go in the lot.

Added amendment to the proposed amendment to add in "Board Member seeking re-election will not be allowed to vote". - motion and support and approved by society

- Article 8: Principal Pete Van Velzen gave the principal's report. Pete reported on the new teachers that will be joining the staff. He gave thanks to the teachers that are leaving or retiring. Pete thanked all the different people that help our school work.
- Article 9: Matt Vande Vegte presented the Scrip Report. Earnings for the year was \$14,570.00 which was an 6% decrease from last year. Scrip paid out \$9,395.00 for tuition and hot lunch to 4 different schools. The school received \$4,000.00 for their share of the earnings. The Scrip checking account balance is \$6,421.30. There is \$14,733.00 retained for future students. An 11-month CD was opened with most of the balance.
- Article 10: The Hearts & Hands report was given by Amy Stearns. Major fundraisers for the year were cookie baking, pizza sales, and bake sales. Current balance is \$41,601.72 with \$14,750 set aside for 9 square and volleyball equipment. Gross revenue was \$19,396 and total expenses were \$15,515.
- Article 11: Dale Kollis gave the Foundation report. Income this year was \$16,317.20. This includes memberships, interest, donations, and memorials. The checking account balance is \$4,563.07. The Foundation balance is \$598,168.23 The Foundation will pay \$23,137.83 to ICS in the upcoming year.
- Article 12: The Building Committee report was given by Darren Davelaar. He reported that the renovation will include all the class-rooms. Flooring, ceiling tiles, and lights are the main things that will be changed. 9 square will be installed on the playground and a new volleyball set will be ordered. Dumpster lids need to be tied down as things are blowing out. Matt Vande Vegte and sons will be doing the mowing.
- Article 13: Election results were shared: Matt Vande Vegte was elected to the school board. Jim Bleeker and Mike Knobloch were elected to the foundation board.
- Article 14: Josh Van Grouw presented the 2025-2026 proposed budget of \$701,500.00. A motion was made, seconded, and carried to approve the budget as presented.
- Article 15: Todd Reinke thanked Jim Bleeker, Dale Kollis and Darren Davelaar for their service on Foundation Board and School Board.
- Article 16: Discussion was held about having women serve on the school board. The Board will discuss and send out a survey in the future to give guidance.
- Article 17: The concept minutes were read. A motion was made, seconded, and carried to approve the minutes.
- Article 18: A motion was made, seconded, and carried to adjourn.
- Article 19: Josh Van Grouw closed in prayer.
